- Mr. Galpin spoke about the proposal by Marazoff Assessing Services for assessing services in the amount of \$43,720.00 for 2013.
- Mr. Fullerton questioned why the amount was not put aside so the assessment could be done all in one year.
- Mrs. Campbell explained that by doing one quarter of the town every year kept the price constant every year which left only sales analysis and value setting to do in the fifth year. She said this method seemed to run smoother than trying to do everything in one year.
- Mr. Galpin said \$10,000 had to be added, to cover the seconded year of the cost for the services of George Sansoucy for the assessing of the town's utilities, which is being paid over a five-year period.
- Mr. Galpin asked Lauralee LoMonaco for the wage scale for the non-union employees. He said the police are receiving a 2.2% increase, dispatch is receiving a 2.5% increase and the town employees in the union are receiving a 2% increase.
- After a short discussion Mr. Galpin made a motion to increase the wages for non-union employees by 2%. Mr. Fullerton seconded the motion. The Board voted all in favor.
- Mr. Venezia made a motion to adjourn. Mr. Fullerton seconded the motion. The Board voted all in favor.

The meeting was adjourned at 8:37 p.m.
