Chair Head called the Hillsborough Conservation Commission (HCC) meeting to order at 7:00 pm.

VISITOR BUSINESS

Jim Callahan, Attorney for Beard Brook Realty – Easement Review (Antrim Rd. (M 11L, L 311). Chair Head introduced Attorney Callahan. The HCC reviewed the Town Attorney's comments on the proposed easement. Suggestions included getting DES (Department of Environmental Services) approval about the State as third party easement holder. After discussion, Attorney Callahan agreed to ask the principal about removing the limitation about access being "only" through the one location on the Second New Hampshire Turnpike.
