MINUTES

1. September 19, 2019

1. **2019 Activities List**
 - a. **Prioritizing areas for protection.** Linda White reported she had completed property list but still needed to complete adding info to map.
 - b. **Signs – House Rock / Old Mill Farm** – Roger Shamel had sent info that the price was \$390 each with no quantity discount. The consensus of the Commission was to do the House Rock sign this year and the Old Mill Farm one in the spring assuming fund availability in next year's budget.
 - c. **Confluence Trail** – Richard Head shared copies of a draft RFQ (Request for Qualifications) he had prepared. The HCC reviewed it and made suggestions. Richard will make the changes agreed upon and send to list of previously interested contractors. John Segedy and Richard Head will find list.

NEW BUSINESS

1. **Riverwalk – Charrette Report suggestions.** John Segedy reported that Robyn Payson had discussed the report with the "Hillsborough Reborn" community group. During that discussion suggestions were made to add a Kayak / Canoe launch and exercise stations to the property. When it was pointed out that the HCC should be consulted regarding any work on the Riverwalk Ms. Payson said the Commission should come to the report presentation on September 25th. Consensus of the Commission was not opposed to the ideas as long as done with minimal impact to the property. Sam Stark and John Segedy are able to attend the presentation on behalf of the HCC.

2. Easement Walks – Monitoring walks were scheduled for the Olivia Smith easement on October 20th and for the PSNH easement on October 27th. On October 5th Richard Head and Terry Yeaton will finish up work on the Old Mill Farm trail.
