d. Colby Road Forestry Lot (M 6, L 62) – John Segedy reported that Laura Buono had answered his inquiry that the proposed easement (or example thereof) would need to be provided to assessor to determine if he could do assessment.

Richard Head reported that he had spoken with Alison Scheiderer from 5 Rivers Conservation Trust who is willing to attend the next meeting electronically.
