- **b.** Confluence Trail -West Main St. (M 11K, L 330-1) Roger Shamel noted he had sent some comments regarding the draft RFQ. Richard Head suggested that the RFQ process may be more cumbersome than it needs to be. He suggested having a few potential contractors attend meetings to discuss the HCC's needs. Richard Head will reach out to Ann Poole (previous responder to RFQ) and Terry Yeaton will reach out to a few other companies.
- **c. Old Mill Farm Subdivision,** Beard Road (M 8, L 106 et. al. & M 11E, L 9 & 9-1). Chair Head noted they were still waiting for the easements to be received from the owners Attorney, Andy Sullivan.
- **d.** Rowe Marsh (M 9, L 99). Chair Head reported he spoke with Mr. Siciliano who estimated a cost of \$525 for a Mylar of plan. It was suggested that \$1,000 should cover that and marking the access easement.

- **e. RV Park,** Carr Road (M 1, L 21-1 & 27). Chair Head reported that The Washington Planning Board had made comments about the project. He is planning on attending the continued hearing on January 6th.
- **f.** Conservation Land Discussion The HCC discussed the four potential properties. After discussion the consensus was to prioritize them in the following order: 1. East Washington Road property; 2. Bog Road property; 3. Colby Road property; and 4. Windsor Road property. Richard Head also noted he was awaiting information from 5Rivers to continue assessment process.
