HILLSBOROUGH CONSERVATION COMMISSION

January 21, 2021 Virtual Meeting on Zoom Platform Approved Minutes

Chair Head called the Hillsborough Conservation Commission (HCC) meeting to order at 7:00 pm and read Emergency Authorization for virtual meeting – see Appendix 1.

Members were polled indicating their presence and any others at their location:

Richard Head, Chair – no one else present; Linda White, Vice-Chair – no one else present; Terry Yeaton – no one else present, & Richard McNamara – no one else present, Sam Stark – no one else present.

Also attending: John P. Segedy, Recording Secretary & Alternate; Erin Amadon, Town 4 Trail Builders LLC.

VISITOR BUSINESS

a. Erin Amadon, Town 4 Trail Builders LLC. Chair Head introduced Ms. Amadon who described her company and both her own and the company's experience. She noted that although she is located in Maine, she had worked locally on the accessible trail at Crotched Mountain Rehabilitation Center. Chair Head shared a map of the proposed trail location. There was discussion of the possibility of making the trail accessible and the greater expense to do so. Richard Head inquired about the need for delineating the wetlands that would need to be traversed. Erin Amadon agreed that it would be needed and that it would be easier for her to make recommendations after that was done. Upon inquiry she noted she does not have a wetland scientist on staff but would be able to find one. She also noted that the company would be able to either do design work or manage the whole project start to finish. Chair Head explained he would be arranging a site visit in the spring so that interested potential contractors could see the conditions on the ground.

Ms. Amaden left the meeting at 7:40 pm.

The HCC briefly discussed the possibility of doing the wetland delineation first (this year).
