March 2, 2021

Virtual Meeting on Zoom Platform

Approved Minutes

Chair Head called the Hillsborough Conservation Commission (HCC) meeting to order at 7:05 pm and read Emergency Authorization for virtual meeting – see Appendix 1.

Members were polled indicating their presence and any others at their location:

Richard Head, Chair – no one else present; Terry Yeaton– no one else present, Richard McNamara- no one else present.

Also attending: John P. Segedy, Recording Secretary & Alternate (Store workers present); Jedediah Talbot, OBP Trailworks, LLC.

John Segedy was appointed to vote in place of a vacancy.

VISITOR BUSINESS

a. Jedediah Talbot, OBP Trailworks, LLC - Chair Head shared a map of the subject property and described the proposed project. He reviewed the HCC's plan to have a site visit in the spring before receiving proposals.

Jedediah Talbot told the HCC about OBP Trailworks. He said they do trail and design work primarily in Maine & New Hampshire. He said they do remote back country rock work, also some accessible trails.

Richard Head asked if they had wetland personnel in house. Jed replied no but that they pull people in as needed. He said they could get permits but they are more familiar with Maine. He would recommend that the HCC reach out to someone else for wetland work.

Richard Head asked if a boardwalk was needed if that was something they could do? Jed answered that they specialize in dirt work and would partner on boardwalks.

Richard Head asked if they were interested in participating in the site walk in May? Jed answered that he or another representative would attend.

Jed asked what the length of the proposed trail was? Richard Head answered that it was about 1 mile.

Jed asked how wide the trail would be. Richard Head answered they didn't know yet.

Jed asked what kind of budget they were looking at? Richard Head said they wanted to get proposals and then see what was available for grants.

Jedediah Talbot left the meeting.
