

CHAPTER 152

SOLID WASTE FACILITY

GENERAL REFERENCES

§ 152-1 Facility designated.

The area hitherto established as the Hillsborough Sanitary Landfill, or any other area hereafter so established, shall be considered as the Hillsborough Solid Waste Facility as the phrase is used in this chapter.

§ 152-2 Permitted users; unauthorized use.

A. Authorized use. All persons, firms or corporations and their agents whose residences (temporary or permanent) or places of doing business are within the corporate limits of the Town of Hillsborough and such other towns as shall have written permission from the Selectmen of the Town of Hillsborough shall be privileged to use the facilities of the Hillsborough Solid Waste Facility. The purpose of the Hillsborough Solid Waste Facility is for the processing of waste generated solely within the herein named towns.

B. Unauthorized use prohibited. No person, firm or corporation, other than those designated in 152-2A shall enter into or upon any portion of the Hillsborough Solid Waste Facility or use said area for any purpose whatsoever, and no refuse originating outside of the towns herein named shall be placed in the Hillsborough Solid Waste Facility.

§ 152-3 Permit stickers.

A. Permit sticker required. All persons or businesses eligible to use the Hillsborough Solid Waste Facility area shall be issued a permit sticker biannually at the transfer station.

B. Issuance of Hillsborough Solid Waste Facility permit stickers. Proper identification will be required at the time of issuing the permit.

(1) Car registration.

(2) Utility bill.

(3) Property tax receipt.

(4) Rental lease.

C. Duplicate permit stickers. A person or business entitled to a permit sticker may, upon request and upon showing of need, be issued one or more duplicate permit stickers.

D. Temporary permits. Any person or business not owning property or residing within the herein named towns may be issued a temporary permit for the purpose of hauling waste to the Hillsborough Solid Waste Facility, if that waste has been generated within the towns herein named and the owner of the property where the waste is generated would be eligible to use the Hillsborough Solid Waste Facility. Temporary permits are issued at the transfer station and are subject to such fees as may be set by the Hillsborough Board of Selectmen.

§ 152-4 Attachment of sticker to vehicle.

The permit sticker shall be attached to the lower passenger side of the windshield.

§ 152-5 Entrance without sticker prohibited.

No vehicle shall enter the Hillsborough Solid Waste Facility area unless the permit sticker shall be attached thereto as set forth in § 152-4.

§ 152-6 Limitations on use.

The following limitations on the use of the Hillsborough Solid Waste Facility area shall apply:

A. Refuse, garbage, empty cans and bottles, glass, paper boxes and the like must be deposited in that section then being maintained as a transfer station, recycling center and demolition area.

B. Metals shall be deposited in an area designated for the purpose; metals: ranges, hot water heaters, microwaves, washing machines and dryers.

C. Refrigerators and freezers shall be deposited in an area designated for the purpose, and all doors of appliances must be removed before being deposited. There is a minimal fee for each item.

D. Wood and construction items, i.e., shingles, sheet rock, bricks, etc., shall be deposited in a designated area. A fee is applied.

E. Recycle all glass, paper, cardboard, aluminum, tin and plastic Nos. 1 and 2 in the proper containers in the recycling center.

- F. Rinse all containers before recycling.
- G. No plastic bags allowed in any container in recycling center; throw away in designated barrel.
- H. No hazardous medical/infectious waste.
- I. No hazardous waste (i.e., pesticides, motor oil, etc.).
- J. All trash (nonrecyclables) must be contained in a clear plastic bag or an open container that can be easily inspected for its contents.
- K. Anti-freeze and oil in a designated area.
- L. Brush and clippings in a designated area.

§ 152-7 Obedience to rules, instructions and signs required.

All persons, firms and corporations or their agents having the right to use the facilities of the Hillsborough Waste Facility, as in this chapter provided, shall abide by and conform to all the regulations herein provided.

§ 152-8 Loitering and alcoholic beverages prohibited.

Loitering or drinking alcoholic beverages in the Hillsborough Solid Waste Facility areas is prohibited.

§ 152-9 Hours.

No person, firm or corporation or their agents having the right to use the Hillsborough Solid Waste Facility areas, as in this chapter provided, or any other person, shall be permitted to enter upon or use the area for any disposal operations except during the hours specified by notice posted at the gate at the entrance to said Hillsborough Solid Waste Facility.

§ 152-10 Removal of articles from facility areas.

No person, firm or corporation or their agents shall, except by permission of the Selectmen of the Town of Hillsborough, remove any article or object which has been deposited and left at the Hillsborough Solid Waste Facility. Exception to this would be the swap shop at the recycling center or such areas as designated by the Hillsborough Board of Selectman.

§ 152-11 Penalties for offenses.

- A. Any person or business found guilty of violating any provision of this chapter shall be deemed guilty of a violation and shall for the first violation be given a written warning; for the second violation be given a fine not to exceed \$60. The third violation will result

in the violator being denied the right to use the Hillsborough Solid Waste Facility for a period not to exceed 12 months.

B. Examples of violations are:

(1) Not separating recyclables.

(2) Not cooperating with guidelines and/or attendants.

(3) Not displaying sticker properly.

(4) Leaving trash/recyclables at the gate when Hillsborough Solid Waste Facility is closed will be considered littering and subject to charges and fines in accordance with New Hampshire RSA 163-B and 265:102 (littering statutes).

§ 152-12 Severability.

In the event that any section or part of this chapter shall be found to be void or unenforceable, it shall be deemed separate and shall not affect the remaining parts or sections.

§ 152-13 Effective date.

This chapter shall be effective as of September 1, 1997.
