CALL TO ORDER:

The meeting was called to order at 7:00 p.m. by Chairman Herman Wiegelman.

OLD BUSINESS:

Major Site Plan Map 25/Lot 19

60 West Main Street Bara Dental Ed Forster

Planning Director Robyn Payson said as per the memo in the packet distributed to the Board, the engineering review has been completed to the Town's third party reviewer's satisfaction, and all outstanding issues around drainage, sedimentary and erosion control have been addressed. Therefore she felt it would be appropriate for the application to be approved with conditions.

The site walk scheduled for 4:00 p.m. that afternoon could not take place due to the applicant's representative's inability to attend. A the site walk, John Segedy, attending as a member of the public also stated that the site walk had not been properly noticed, because to his knowledge one must reschedule a site walk at the site. The question has been submitted to the New Hampshire Municipal Association.

Following discussion Mr. Fullerton made a motion to approve the application with the following conditions:

- 1. The silt fencing for sedimentary and erosion control measures shall be inspected by a licensed engineer once they are installed to ensure they are working as intended.
- 2. Parking lots are to be swept at least annually, in the spring.
- 3. Site walk to be held March 5, at 5:00 p.m. at the Bara Dental site.

Mr. Baker seconded the motion. The Board voted all in favor.

281 Second N.H. Turnpike Hillsborough Corner Store Gordon Davis

Mr. Davis presented his ideas for renovating the Hillsborough Corner Store and re-establishing the gas pumps. This is a multi stage project that will begin with the restoration of the gas sales business followed by a complete renovation of the building and site.

Mr. Wiegelman said it use to be a country store with gas pumps so he doesn't see how the Planning Board would be involved as there is no change of use.

Ms. Caron mentioned that there have been zoning changes since the gas pumps were removed.

The Board agreed they would like to see the site plan for the pumps and tanks and would then schedule a site plan review.
