### Zoning Changes Education Session: 7:15 p.m. to 7:40 p.m.

Mr. Wiegelman introduced Mrs. Payson who had prepared a power point presentation on the proposed zoning changes.

Mrs. Payson said from research she found that the Zoning Task Force had worked for about two years on this project. She said they had looked at the zoning ordinances for other towns in this area and proposed changes for the 2012 Town Meeting. She added the proposed changes were not adopted.

Mrs. Payson said this update focuses on reorganize, the addition of defined use and an easy to understand chart of uses. She went on to explain the proposed zoning changes in detail and the wording of the warrant article.

Mrs. Hahn asked if this article needed a two-thirds vote and how was the Planning Board getting the word out to the public.

Mrs. Payson said it will be a majority vote. Mrs. Payson said there have been articles in the paper and a pamphlet has been sent out. She has spoken to the EDC and Chamber of Commerce.

Mr. Cherrington said the brochure references a "Savings Clause" but is not referenced in the proposed changes.

Mrs. Payson said it is in the section labeled "Use Standards".

Mr. Segedy said the process of applying needs to be simplified.

Mrs. Payson said this may be true but we can only work on one thing at a time.

Mr. Segedy asked several questions regarding definitions and permitted uses of structures.

Mrs. Payson and the Board said structures are governed by the building department and set back requirements.

The presentation concluded at 7:40 p.m. and Mr. Wiegelman thanked everyone for coming.
