**Call to Order:**

The meeting was called to order at 7:00 p.m. by Chairman Herman Wiegelman.

**Minutes:**

Ms. Poole asked for her name to be corrected on the bottom of page two. She said Mr. Fullerton's statement made at the last meeting should not be included in the minutes and should only be summarized.

Ms. Caron agreed.

Ms. Poole made a motion to omit Mr. Fullerton's statement and have it changed to a summarization.

Mr. Fullerton made a motion to approve the minutes as written. Mr. Solomon seconded the motion. The Board voted: Mr. Fullerton, Mr. Solomon and Mrs. DeForest – yes; Mr. Clohessy, Chairman Wiegelman, Ms. Caron, Ms. Poole – no. The motion failed.

Ms. Poole made a motion to approve the minutes as presented with revisions. Ms. Caron seconded the motion. The Board voted all in favor except for Mr. Fullerton and Mr. Solomon who abstained.

**Meeting:**

Chairman Wiegelman recognized Sean Burt from Tooky Mills Pub.

Mrs. Payson said the purpose of the discussion tonight is regarding his having live music at his establishment. She said one of his neighbors sent an email not objecting to the music but with concerns regarding the possible loudness and lateness of the music.

## Meeting Minutes July 2, 2014

Mr. Burt said it will be more acoustical music. He said last week they were done by quarter to nine, people brought lawn chairs to sit on the sidewalk to listen and it would not be every week. He added it would probably on Sundays and maybe earlier on Thursdays.

Ms. Caron suggested letting the public know by way of notices or advertising in the paper.

Mr. Burt agreed.

Chairman Wiegelman didn't see any reason for a public hearing but only go on the record with any limitations the Board wants to place on this endeavor.

Mr. Burt said the music wouldn't be every week but occasionally on a Thursday or a Sunday. He said Sundays would be in the afternoon but in no case would he go any later than 9:00 p.m. weather permitting. He said it would be dinner music with the speakers pointed toward downtown not a concert.

Ms. Poole summarized on Thursday or Sunday no later than 9:00 p.m. on the deck, weather permitting and only during the season when the dinning deck is open.

Chairman Wiegelman said as long as he stays within those parameters he should be fine.

Ms. Poole wanted to go on the record as she is a frequent customer at Tooky's and is familiar with the area. She wanted to make it clear so there is no hint of a conflict of interest.

### **Other Business:**

Ms. Poole said on Thursday, June 26 she attended a presentation in Concord hosted by the American Planning Association, New Hampshire Housing, Plan New Hampshire and Vibrant Communities with the guest speaker Howard Mansfield from Hancock. She said his books and lectures on his thoughts on planning for villages in New Hampshire are outstanding.

Mrs. Payson said the town applied for six projects to the Comprehensive Economic Development Strategy through the SNHRPC and the CNHRPC. She said they have received over thirty projects and the completion of the Woods Woolen Mill cleanup is number one on their list. She said there is still a ways to go but if we can stay near the top of the list we should be able obtain matching grants.

### **Adjournment:**

Chairman Wiegelman entertained a motion to adjourn.

Ms. Poole made a motion to adjourn. Mr. Clohessy seconded the motion. The Board voted all in favor.
