## **OLD BUSINESS**

#### 1. Trails

No work reported.

#### 2. Markers

Terry Yeaton shared prices he had obtained from "Adrian Name Plates". He noted that they don't do triangles or diamonds that the Commission was looking at for marking trails. The HCC discussed the prices given as well as the cost of using reflective material. Consensus was cost to make reflective was prohibitive but perhaps they could add reflective dots to regular markers. John Segedy suggested they look for alternative sources that might have triangles or diamonds. Consensus to continue discussion at future meetings.

# 3. North Hillsborough Property Conservation

Linda White reported on communication with Ann Eldridge of Bradford Conservation Commission (BCC) that they will be contributing to the costs but want to see what the need is after fund-raising. A BCC member may be able to loan money to keep things moving if needed. Some of the money raised by the Anti-Corvus group may be donated to this cause. It is also anticipated that some fund-raising will take place. The consensus of the HCC was to wait until after fund-raising to determine making a contribution.

It was suggested that as part of the Commission's plan to put signs at its properties, that duplicating the original sign would make sense. He also noted that a ceremony was held at that time and that 2018 would be the 50<sup>th</sup> anniversary of that ceremony and would be a good time to repeat that ceremony and put up a new sign.
