October 20, 2016 Hillsborough Town Office Approved Minutes

Acting Chair Yeaton called the Hillsborough Conservation Commission (HCC) meeting to order at 7:05 pm. Ann Ford & John Segedy were appointed to vote in place of vacant positions.

MINUTES

1. October 6, 2016

Richard Head suggested a wording change.

Richard Head moved: *To approve the minutes of October 6, 2016 as amended.* Ann Ford seconded. Motion passed 3-0-1.

OLD BUSINESS

- 1. Trails Terry Yeaton reported he had flagged the new loop for the proposed trail on the Old Mill Farm property.
- After discussion the consensus of the Commission was that the thinner of the two samples (.012 gauge) was fine for the Commission's purposes. The Commission discussed the prices listed in the catalog. Terry Yeaton noted that there was \$400.00 in the supply line item of the Commission's budget. Richard Head said that the price for 250 would be \$207.50 or 500 would be \$280.00. John Segedy reminded the Commission that there was also a charge for setup/layout for the first order and that the Company had said that was usually \$43.00 (but could vary). Consensus of the Commission was to get 500. Terry Yeaton noted that the catalog indicated that the prices listed were without mounting holes. The Commission discussed the benefit of having mounting holes. After discussion the consensus of the Commission was that it would be worth five cents extra per marker (\$25 for 500) to have holes in them.

Richard Head moved: To authorize John Segedy to inquire on the cost for adding mounting holes to the markers and if equal to or less than five cents each to proceed with placing an order for 500 markers as discussed.

Ann Ford seconded. Motion passed 4-0.

- **4. Easement Monitoring** Terry Yeaton reported that he had walked the PSNH easement. Richard Head and Terry Yeaton are still planning on walking the Olivia Smith easement on November 6th at 9:00. Terry Yeaton reported difficulty getting into the Easement monitoring log on line. The Commission discussed the website.

NEW BUSINESS

1. **Downtown Lighting** – Terry Yeaton reported that he had heard that the Town was going to be replacing the lights in the downtown with LED lights. The Commission discussed recommending that they be sure to make sure they are dark sky compliant. Terry Yeaton said he would convey the recommendation to Laura Buono.
