2. **Thornburn** – The HCC reviewed the draft letter to Ms. Thornburn. A couple of suggestions were made. John Segedy will make the suggested changes and forward the letter to Terry Yeaton to sign and send.

NEW BUSINESS

1. Non-Public Session

Terry Yeaton moved: *For the HCC to enter Non-Public Session pursuant to RSA 91-A:4 II d.*

Linda White seconded. Roll call vote: Terry Yeaton – yes, Linda White – yes, John Segedy – yes.

Motion passed 3-0 at 7:27 pm.

Terry Yeaton informed the HCC that he had received an inquiry asking if the HCC was interested in purchasing a piece of property at M 11H, L 304 for \$29,900.00. This being the property previously suggested as an access point to the proposed easement on the Weatherstone Crossing property. The Commission discussed the property, the price, the easement and the state of the Conservation Fund including prospects for adding to or replenishing the fund.

The consensus of the HCC was that at this time they would not be interested. Terry Yeaton will convey that answer.
