Chair Yeaton called the Hillsborough Conservation Commission (HCC) meeting to order at 7:04 pm.

MINUTES

1. April 6, 2017

Richard Head moved: *To approve the minutes of April 6, 2017.*

Linda White seconded. Motion passed 3-0.

OLD BUSINESS

1. **Membership** – Linda White reported she had forward the final version of the membership appeal article to John Segedy. John Segedy reported he had submitted the article to the two papers and requested multiple publications.
2. **Signs** – Terry Yeaton reported he had ordered the sign for Gleason Falls. The HCC discussed future signs and will review how the first one is received before deciding on other ones. John Segedy suggested seeing about trying to get a piece of granite for a bench also.

Chair Yeaton appointed John Segedy to vote in place of a vacancy.

NEW BUSINESS

1. **Variance** – M 12, L 95

Terry Yeaton recused himself from discussion of this matter as he is an Abutter. Linda White assumed the roll of Acting Chairperson.

John Segedy reported that he had been at the ZBA hearing on the matter. He shared the copy of the plan that had been provided at the hearing and explained the request as being to allow 50' of frontage instead of 200'. He informed the HCC that the hearing had been continued for a site walk on May 13, 2017 at 10:00 am and to be continued on May 15, 2017 at 7:00 pm.

The HCC discussed the proposal and referred to the Town's Natural Resource Inventory. Richard Head said he saw nothing of concern to the Commission. Consensus of the Commission agreed.

Terry Yeaton un-recused himself and re-assumed the Chairmanship.

2. **Trail Committee** – Terry Yeaton said that there has been talk in town about starting up a Trails Committee again. John Segedy suggested that perhaps those people might want to join or help the HCC with their trail work. Terry said he thought they were interested in connecting to the trail in Henniker and the old rail beds.
