Chairman Wiegelman called the meeting to order at 7:01 p.m.

Mr. Reopel commented on the police department's vision for fifteen new cruisers, adding an officer every year for the next three years and adding a dispatcher. The Board agreed this was an issue for the Selectmen.

The Board and Mr. Tardiff continued the master plan discussion.
