Mrs. Payson said the Board's present fee is \$75.00 for advertising. She said the Board has the option of raising the fee.

Mr. Solomon suggested holding a public hearing to adjust the fee in order to cover the cost of publishing hearing notices in both papers.

Chairman Wiegelman entertained a motion to hold a public hearing.

Mr. Solomon made a motion to hold a public hearing with the intent of raising the advertising rate to \$100.00 to allow for publishing in both local papers. Mrs. DeForest seconded the motion.

Chairman asked Mr. Solomon to amend his motion to include the date of the public hearing.
